God intended that marriage remind us of the relationship between Christ and his Church. This phrase from the Wedding Ceremony is a primary guide for what we see as appropriate and non-appropriate use of the church.

1. Warriors Mark Methodist Church (WMMC) is dedicated to the worship of our Triune God and the pastor is a Christian pastor. At no point in any wedding rehearsal or ceremony will anything be allowed that dishonors the Christian faith. The pastor reserves the right to stop the rehearsal or wedding service until such actions cease, or failing that, end the service without completing the ceremony. There will be no refunds in this matter.
2. The bride and groom accept full responsibility for the behavior of the bridal party and all guests.
3. WMMC may refuse to host any wedding.
4. The pastor may refuse to officiate any wedding.
5. All music used in the wedding must be suitable for Methodist worship. Therefore, all musical selections must be approved by the pastor. These arrangements should be completed at least one month prior to the wedding.
6. The pianists at WMMC have the right of first refusal for each wedding. If they are unable to participate, the bride and groom are responsible for finding a substitute, who must be approved by WMMC. These arrangements should be completed at least one month prior to the wedding.
7. Confetti, rice, and glitter are not allowed on our grounds or in our facilities.
8. Separate dressing rooms are available for both men and women.
9. The kitchen and reception facilities are available.
  - a. Our reception facilities will accommodate 250 people comfortably.
  - b. Use of the kitchen requires the presence of an approved kitchen supervisor.
  - c. Any outside catering service requires the approval of WMMC.
10. Janitorial services will be provided by approved personnel only.
11. Sound and technical services will be provided by approved personnel only.
12. Sanctuary furniture is not to be moved.
13. Candles
  - a. You are responsible for all candles used in the ceremony.
  - b. You are responsible for ensuring that wax does not drip onto the carpet. Failing that, you are responsible for the cost of cleaning the carpet.
14. Alcohol and tobacco are not permitted on our premises.
15. The photographer must meet with the pastor at least 1 hour prior to the start of the service to discuss what pictures may be taken during the ceremony.
16. Nothing should be placed on the organ or piano.
17. If WMMC is responsible for printing the wedding bulletins, the information must be sent 3 weeks prior to the ceremony. You will be sent a proof at least 1 week prior via email. You are responsible for purchasing the bulletins. The printing fee for this is \$50.
18. The bride and groom must attend pre-marital counseling sessions.
